  - a. The Board has been investigating the allegation that the team of Chuck Storrey and Vince Landreville operated their competition vehicle on open public highways with one of the team members seated on the hood of the vehicle counterbalancing for a missing hub assembly after the conclusion of the 2010 Galway-Cavendish Forest Rally in August constituting a violation of the CARS Code of Conduct.
  - b. Both Mr. Storrey and Mr. Landreville addressed the Board and answered questions on the matter.
  - c. Mr. Storrey also provided a written statement on behalf of the team.
  - d. The substantive facts of the matter were confirmed by Mr. Storrey and Mr. Landreville.
  - e. After deliberations, the Board has issued a disciplinary penalty to both Mr. Storrey and Mr. Landreville: all points awarded in the 2010 season will be voided, and their competition licenses are suspended for the remainder of the 2010 season.
