# d. Quebec Insurance – Ross

Ross has been in contact with some Quebec competitors with regards to insurance issues. They are currently in contact with companies to see how they can improve insurance to Quebec competitors along with allowing them to compete in Ontario. Ross to continue research.

# 7) OPRC Report – Warren

a. Shannonville Stages Rally (April 12) – Peter Watt Rally has 9 ORRC entries and 12 OPRC entries.

Now have enough workers to run the event. LHFR work day is scheduled on the same day so lost some workers to that. Warren to call Mike Koch (LHFR coordinator) to discuss the situation.

Bruce suggests contacting Robert Roaldi to promote SSR on GuideAuto.com forum to inform Quebec competitors that it's an all racetrack event and therefore no need for insurance.

Peter Watt has sent information to Eric Tremblay & Ivan, so it may have been looked after already.

It was also noted that an OPRC competitor can also enter the TSD rally.

Request to have Road Damage Levies waived as event will take place on the racetrack.

**Motion** to waive Road Damage Levy for SSR 2014 – Haywood/Maynard. Watt and Gulliver declared a conflict of interest and did not vote. Rest of BoD voted in favour. Carried.

Warren asked that it be noted in the minutes that the waiving of the road damage levy for 2013 was requested and approved in June 2012. Should be requested annually for the event if the levy is to be waived.

# **RSO & Insurance – Ross**

Ross has been researching insurance for rally cars in Ontario. Contact has been made with competitors and insurance brokers/companies.

General consensus is to continue the research. We need to encourage competitors to be up front about their vehicles, and in order for the sport to grow the subject needs to be looked into. Bruce asked for the board's approval. All agreed that Ross should carry on investigating insurance in Ontario.
