  - a. RSO awards

Lots of good discussion, with a lot of reading to be done! Plan is to do some shadowing/observing at 1 or 2 events this year.

c. CASC – OR Affiliation – Bruce Has been agreed (through discussion with John & Perry) that MLRC doesn't have to affiliate. MLRC has GL and Event insurance. If next year KWRC wish to go that route, there shouldn't be an issue. For any MLRC member wishing to enter CASC affiliated discipline, an associated membership with SPDA is all

set up and ready (David) as a few members are involved in multiple disciplines needing CASC affiliation.

**d.** Rally Car Insurance – Ross Quebec – No immediate answer, further discussion to be had with Quebec contact, still waiting to hear more. Ontario – Best solution currently for competitors is Facility Insurance.

Results to be added to ORRC standings shortly. Typical Carbado brothers challenges for competitors. David would like to see more competitors out – There were 3 'newbies'

## 7. OPRC Report – Warren

- a. **RSO Website & Current Standings** Bruce to update current standings. Part of new rule set is the Powerstage Point. Discussion with regards to current rules not approved yet (see later section 7. g. OPRC 2014 Rules). Warren will redo results if board wants it taken out but point was made that it also involves a sponsor, so it was decided to keep the current results as they stood.
- b. **Media** Warren debriefed with CDNRally after SSR, and had a few things he wanted them to adjust.

Warren wants to make sure that CDNRally are working with event organizers and have a good relationship with them. According to Peter Watt, CDNRally were pretty much invisible at SSR and were allowed anywhere on stage as long as properly identified. Pete Gulliver has been contacted by CDNRally and invoiced for sponsors – Also supplied them with high res copy of Peterborough Mitsubishi Logo and still waiting on a Canadian Tire Logo

Event recap will be on social media Tuesday April 29 with video online May 7<sup>th</sup> Warren trying to get John Hall to open up social media sharing within CRC to include OPRC – Still waiting on an answer.

c. **OPRC Podium Banners** Have to change centre banner because cars block the sponsors. Better support structure needed for the banners themselves. Peter Watt suggested support poles from Princess Auto (\$4/4ft pole). Warren will look into it. Will be done for LHFR.

### d. Shannonville Stages Rally (Apr 12) - Peter Watt

No stewards report yet. Was the test bunny for the new timing/restart rules, with a number of competitors taking advantage of it.

TSD event "Salmon River Rally" was held in conjunction with SSR and was well received.

### e. Black Bear Rally – Ross

Date has been approved for the rally to run on Sunday July 13, with recce, tech & registration to be held on Saturday July 12. The schedule will be published soon. The committee is formed and all key positions filled. David Maynard – Chief Control Marshal to release "Call for Workers" after LHFR event.

## f. Lanark Highlands Forest Rally – Mike Koch

Event to run Saturday May 3. Currently 15 entries so far (8 less than last year) with several notable entries missing. 1-2 Quebec cars are entered. So far no TSD entries for the Mississippi River Rally.

Very thin on the ground for workers, with a meeting being held later this evening (Apr 28) to re-cast roles and attempt to get more volunteers.

Road is very soft, with only being able to access it for a week. Will more than likely get very rough as day progresses.

Town seems happy with the event and is not bothered with us being there.

Ross to take a look at worker list and mike noted a few people signed up today to fill some spots.

Mike asked for opportunity to discuss re-start rule and how it pertains to LHFR. Discussion with regards to CARS National re-start rule versus regional event. "CARS rule applies only to National Events" (Pete Gulliver)

For LHFR, RSO has not yet approved a restart rule and therefore whatever is in event supp regs will apply. Pete Gulliver and Mike Koch to discuss under Stewards approval.

## g. OPRC 2014 Rules – Warren

Discussion on proposed OPRC 2014 Rules. Revision 7 not yet approved by the board and therefore cannot yet be published on RSO website as new rule set. Roundtable discussion has been only time rules were talked about and Pete Gulliver noted that he'd not yet seen a full new rule set to vote on. He believes the new restart rule conflicts with National rules. CARS state that regionals can adapt their rules, but in cases where an event is both a National and Regional competition, (eg. Tall Pines), National rules will apply. Discussion as to whether having different rules in National v's Regional is a good idea.

Decided that the latest version of the OPRC 2014 Rules (Revision 7) be sent to the Board to check and discuss via email. Important that decision is made, rules are approved and published on RSO website ASAP.

#### 10. Equipment Managers report – Ross Wood

a. General Equipment

LHFR would like to use 2x Radar guns. (RSO recently purchased a new one, \$120 to replace)

#### b. Timing Equipment & TSD Levies

Worked ok at SSR & a special levy was set up for it. One issue with SSR was that they committed to 5 clocks which Newells approved and set up. A couple of days before the event 3 clocks were cancelled. However, these clocks had already been prepped and therefore were invoiced. SSR only paid for 2 so the other 3 clocks still need covering. Discussion into timing levies with it suggested that by continuing to order clocks and not use them will lead to increased levies to performance competitors.

Ross would like to suggest for future events that have a TSD portion and have special requests that the normal fee (OPRC \$35/car) is applied to all cars entering the event. Organizers who then wish to apply for an "allowance" can do so through the Growth Initiatives instead of the Timing Levies.

## Peter Watt declared conflict of interest and sat out of discussion.

It was suggested that we need the current rate scale to have a clause included that covers all entrants including special TSD entries.

Discussion also covered Rallycross rates. Currently Rallycross pays a flat rate (+ transportation) as Rallycross competitors get a lot less seat time, & would be difficult to charge higher entry fees to these competitors to match TSD levies.

#### c. Special Directional Boards – Pete Gulliver

Directional boards for use at GCFR in the quarry similar to use at Targa. They are boards with red triangles with arrows. \$400 for 40, thought was to split costs between RSO and PSMC. However, now thinking of making it a PMSC expense and putting sponsors names on the 3 sides to pay for it.

Currently awaiting MNR approval to utilize a 2<sup>nd</sup> road and therefore quarry will not be needed. If not heard anything by mid-May the directional boards will be ordered.

#### d. Limestone Ridge Rally (TSD event part of GCFR event) – Pete Gulliver

Going to be a little different to SSR and LHFR. It will be a series of elapsed time which will control speeds, with increasing penalties for excessive speed. Speeds will be as low as other TSD events. Event is going ahead and insurance is already organized. Pete Gulliver asked for RSO to sanction the event (as per the rule book) Peter Watt proposed a motion to approve sanctioning of Limestone Ridge TSD Rally as a club event pending approval of TSD Supplementary Regulations by VP Navigational David Maynard.

After some discussion it was decided that this was unnecessary as all other TSD events only have to operate under ORRC rules and do not have to come to RSO Board for sanctioning. It was therefore agreed that Limestone Ridge TSD Rally is sanctioned by being affiliated and therefore does not need separate approval from RSO. The motion was then withdrawn.
