# 4. CARS update – Peter Watt

April 20, 2015 Canadian Association of RallySport Report to RSO

- a. Items of possible interest to RSO from the CARS Board Meeting of March 18, 2015.
  - i. New Bowes Media Marketing Person to start April 1. 50% of time to CARS.
    - Safety Plan Templates for Rally Cross, Rally Sprint, and Test Days needed soon.
       Peter volunteered to assist Terry in these if he (Terry) wishes. Terry did not wish (April 16).
    - iii. Licence Applications and Medical Self Declaration wording changes made.
    - iv. Website functional specs almost developed.
    - v. Vehicle Tracking RFP will be sent out.
  - vi. MOU between CARS and Events presented will go to organizers for input.
  - vii. Rally Sprint Insurance will be \$110 per car. Analysis at end of year will determine rates for next year.
  - viii. Rallye Tuque ran one vehicle on WRC studs. Result car was faster by considerable amount but road damage and pre event preparation make it unacceptable.
  - ix. Issues of sanction authority have developed in Quebec and the CARS president is mediating and clarifying the various positions.

- b. Items from April 16, 2015: A quorum was not present so no votes were taken, but the agenda was discussed and approved in principle with items to be voted at next meeting with a quorum.

# 5. Old Business –

a. **RSO AGM** – Overview of the AGM from March 21

AGM Minutes have been circulated to BOD for revision & with a couple of minor adjustments they can now be posted on the RSO website as *unapproved minutes*.

Following the Motion put forward to form a committee to address the Regional Rally Director situation within the RSO Board, Alasdair Robertson has agreed to head the committee along with members: Bruce Leonard, Trevor Hancher, Pete Gulliver and Martin Loveridge.

2015 AGM location – Needs to be organized by September 2015 in order to secure it. Talk of moving the location to somewhere more easily accessible; Coburg, Port Hope etc Distances aren't much different for those that have to travel the furthest, but costs are higher. Further research needed. Location up for review the first RSO meeting in September.

CDNRally/OPRC 2015 Partnership – Warren – updates on sponsorship.
 CDNRally are working on better strategies to obtain in-car footage. They are also interested to see how Mark Williams' tracking system can be incorporated into the coverage.

**OSM** – Warren to continue discussions with OSM with regards to sponsorship for 2015 season. OSM still interested in some form of sponsorship but 2015 program may differ slightly from 2014. Details will be in place before LHFR, May 2<sup>nd</sup>.

**CLEARWATER DESIGN** – Worker's prize organized for LHFR but further sponsorship for the remainder of the season has not yet been decided.

c. Vehicle tracking – EZTrack – Pete G – Mark has travelled the LHFR stage roads researching signal coverage for the equipment. It was found that the new Umpherson's stage road had 100% coverage (as well as transits), however, Lavant Mill stage road has approx. 50% coverage.

Equipment and details are all set for LHFR. It's unsure how the system will deal with Lavant Mill stage road, but testing at the event will show how it deals with such situations.

TSD events – Bruce to address usage of equipment for a TSD event in the near future with Mark at LHFR.

We see Chief Scrutineer as being responsible for Rally Sprint vehicle scrutineering whether personally or if unable to attend, the event scrutineer must be approved by Chief Scrutineer to ensure it is being done correctly.

- f. First Aid Course Warren Course was held March 28, 2015. Initially 6 signed up but that dropped to 4 on the day. All new rally folk, not necessarily for licences. Still cheaper for competitors than a regular first aid course. Martin explained KWRC run an emergency first aid course every 2-3 years. Still good value to offer for competitors
- **g.** Rally Insurance Ross Situation still improving. A second company has looked into similar ways to reduce costs for competitors and continues to research lowering costs on facility insurance.

Currently RSO carries separate insurance for RSO Equipment trailer. New coverage may now include this. We need to double check if this is the case.

LHFR is fast approaching. Roads were green crewed last weekend. New stage is in superb condition whereas the regular Lavant Mill stage is still a little wet. The provided stage notes are almost complete, and all check points are marked out ready to go.

Currently 11 entries, the MotorsportReg.com website is slightly more up-to-date on the entries than the event Website.

Next event after LHFR will be Black Bear Rally. Organization is progressing nicely, with rally sprint on the Saturday and rally on the Sunday.

#### a. Timing Operations Budget

After contact with the Reviewer of the Books, Dennis Wharton, the 4yr report on timing equipment budget was deemed too laborious to undertake. Looking at the numbers over the past 2 years shows only a slight deficit. It was suggested that we research increasing timing equipment fees to events. If geographical location is used to generate fee this will not change total income & will require advanced notice, especially to those clubs that are located the furthest distance away. A better solution, that will also generate increased income, would be to increase fees in general. Fees for 2015 will stay the same. RSO to look into increasing fees for 2016. b. **Equipment Report** – RSO Trailer is due for its safety. In general the trailer is in good shape, however some work is currently being done on the brakes which weren't working, before the safety can take place.

# 12. New Business –

a. RSO Website Security – Bruce

RSO Website was recently hacked. Very minor and was restored quickly. No secure information kept on that site.

The ORRC registration page which is separate definitely needs a SSL Cert. Bruce to discuss the benefits of the site with ORRC organizers. If it's deemed necessary the SSL Cert will be purchased (\$45), if not the site will be taken down.

# b. 2014 Club insurance Policies & list of events - Peter W

The list of club events on the 2014 insurance seemed to be different to the events that took place over the season. Peter W wished to clarify which events took place. It's possible that events were charged for a range of dates ie. 5-9 events rather than individual events.

An idea was put forward to issue log books for event volunteers/marshals to keep track of event experience. Similar to car log books, they would be filled out at each event documenting the volunteer's role and responsibilities.
