Minutes

- 1. Approval of/additions to agenda

3. Treasurer's Report - David

The report was separated as requested at the last meeting with regards to timing equipment, tracking levies & road damage cost/levies. Easier to read.

- 4. CARS update Darryl Malone
 - a. June 21 CARS board meeting summary
 - i. Insurance issue in BC- The authorities observed the Rocky Mountain Rally. Feedback from ICBC is that they were very impressed at the professionalism and no issues at all with competitors driving rally cars on the public roads. It was stated by ICBC that rally Cars are every bit as safe as regular cars from what they saw at Rocky. Moving forward ICBC will issue TOP's for any CARS sanctioned event. They went on to talk about a longer term solution being an acceptance by CVSE of rally cars safety as being equal to or greater that the requirements. At that point ICBC would issue insurance.
 - ii. Mike Dyer from Alberta sent a scrunitneering report after Rocky to each of the regional tech people. There was a collision with a seat mount failure due to improper mounting. Discussion is ongoing. Likely will be sending out a bulletin to license holders reminding of the importance of proper seat mounting. Also discussed difficulties in doing full/proper tech inspections due to limited time and people.
 - iii. Rallycross helmet rule change
 - iv. Rallysprint rule proposals from Kelly/RSO discussed and approved. See latest CARS bulletin.
 - v. Admin rule change discussion, see recent CARS bulletin.
 - vi. Concussion Test the test protocol is at a point to be review by the CARS medical advisor. Will likely require concussion test be insert in route books close to redcross/ok page.
 - vii. Technical rules committee moving along with proposed O4WD rules change suggestions to reduce costs. CARS board approved revised mandate (available on request).

Focusing on exploring the following areas:

- 1. Boost pressure limitations on O4WD Forced induction vehicles
- 2. Displacement limits for O4WD NA vehicles
- 3. Cross platform O4WD vehicles
- 4. O4WD vehicle weight limitations
- 5. Tire limits
- 6. Service crew limits

- 7. Service item limits
- 8. Fuel type limits

Question from Alasdair: Daryl's notes on the CARS front raise one point which we might consider. Are changes to class structures here going to bring us into alignment with Martin and Tim's series? In the long term, this would be a net good for both series

Answer: Original intent was to align as close as possible to ensure smooth transition crossing the border. However, after looking into it, there are some rules that are too different. They will attempt to align as much as possible.

With regards to all the proposed rule change ideas, Darryl wants to ensure they don't affect the majority of competitors.

- viii. Keith Morison made a presentation to the board asking for support to explore the possibility of hosting WRC Canada. The presentation reviewed the recent history of discussions with the WRC dating back to 2012. It reviewed the general concept of utilizing a separate Not for Profit corporation for the purpose of organizing, promoting and fundraising. A motion was made to support the ongoing exploration efforts. The motion was seconded and supported by the board. ALSO AN ITEM IN NEW BUSINESS DISCUSS LATER
- ix. The Ottawa Sports Car Club was approved for affiliation.

 - i. Ambulance bill for Rocky. In the end it was referred to the Admin Rules Committee, but the question arose as to why Rally West was involved in it at all and the general consensus was it would be a bad precedent for either CARS or a Region to take on responsibility for this.

 - Baie terry submitted a written report fantastic event many outstanding features – great promotion and spectator attractions
 - very strong , well-organized committee adjusted quickly and appropriately to all issues
 - 36 entries only one true nacam entry, which is disappointing
 - Defi the committee has responded very well to the concerns expressed by cars re last year's event. Great improvements in security. Committee has been expanded to include numerous highly experienced people. CARS board approved motion to approve sanction of the event in the CRC

6. **ORRC Report – Darin**

There's not much happening in the nav rally world right now other than a SNATR on August 5th out of Elora which is being organized by first-time routemaster, Brandon Pace, with the assistance of the usual KWRC veterans.

There hasn't been an ORRC event since our last meeting and there won't be another for a couple more months. Dennis Wharton did send me some suggested rule changes for the ORRC series and I'll be going over them and discussing them with other veterans of the series before bringing them forward to the board.

7. OPRC Report – Warren

- a. Rally of the Voyageurs Went well. 14 entries (2 non-licenced). 11 finishers. Great battle at the front of the pack. Positive feedback from the competitors. One competitor ran 2 stages with a badly broken windshield before the scrutineer caught up with them and DNF'd them. Organizer had one complaint with regards to media that hadn't signed on as media & was moving about the stages. Warren to talk to the stage control marshals to understand their interaction with the media person. He will also make sure that the media person in question knows to contact organizers and work with the organizing team.
- Black Bear Rally Aug 11/12 Event insurance certificate is issued, couple more things the organizing team is working on. Low entries so far. Work day this coming weekend. A lot of road work been done in preparation (stone work, grading etc)
- c. **Rally Defi** Supp regs are now out some changes had to be made with regards to regional re-seed but now corrected.

8. Legislative Affairs Report – Alasdair

There is no immediate update on the MTO radio ban. The decision is now at the Deputy Minister level and won't likely be resolved until the fall.

9. Scrutineer's report – Steve van Rees, Chief Scrutineer

We need more people to get involved/trained in scrutineering. There is a list of volunteers that have worked Tech at the Tall Pines. Need to reach out to some of them. Jason & Jennifer Crandall were put forward as first ones to contact.

10. Equipment Managers report – Ross Wood

a. Timing Equipment – The two clocks that needed fixing & were going to be sent to the UK have now been fixed. Andrew Miller has fixed them. Foam inserts in the cases have started ripping \$200 per case to fix them – getting done 1 at a time. Rally BDC went well & Defi timing team is organized and ready to go after BBR

11. Growth Initiatives – Last meeting Tues July 18 –

- **a. Rally Radio** good discussion on preparations for Rally radio at Tall Pines. Working on some additional ideas for the event also.
- **b. OPRC event surveys to Volunteers & Competitors** Survey is just getting last checks & will be sent off the ROTV volunteers & competitors. Similar survey will be prepared for BBR with event specific questions.
- c. Video Title Page Peter Mac is helping create a page that competitors can download to add to their in-car footage with the OPRC logos, and event sponsor logos. Competitors can download from the OPRC page and event page First event trial will be BBR
- **d. CDNRally Media program 2018** Peter to get back to us with costs for 2018 media program and we are working on sponsorship ideas as we want this back for 2018.

12. New Business -

- a. Egan Road Repairs Ross Roads being repaired. 2 loads of stone & 4hrs machine work. Also repairs on the hill with the major damage. Road work day on Sat july 29. Going to do the best they can to improve the road. Loggers aren't in there at the moment but they usually help us out. 10 people signed up to help out so far.
- b. WRC Darryl CARS have been approached a number of times with regards to the possibility of a WRC round in Canada. Not something that will happen in the next couple of years but research starting now into the costs & logistics involved. CARS BOD has given permission to start looking into it. No financial risk right now, just researching.
- **c. Burnt River for Rallycross** Darryl has been approached again to run a rallycross at the Burnt River facility. Mixed feelings within the BOD as to whether it's a suitable location for that level of event. Would be helpful if another set of eyes could go see the facility.

Bruce to visit Burnt River. Darryl also has a video that was made of the road & will send out to the BOD.

Even if the \$ amount is set at a certain level from ASN perhaps CARS can help out and reduce costs.
