- 3. Treasurer's Report David Financial document was sent out prior to the meeting.
 - Banquet tickets needs to be added to AGM income \$120
 - Slightly over budget for Awards lunch

4. CARS update - Darryl Malone -

No CARS meeting since RSO AGM. Following notes are the from the update given at the RSO AGM:

- a. CARS BOD very active, regular meetings, John Hall is a very strong president
- b. CARS Rules -
 - i. 2 rules committees Technical Rules Committee and Admin Rules committee – their job is to go over any new rule suggestions/rule updates & present to CARS BOD.
 - ii. Instead of waiting until the end of the year, rule changes are now done throughout the year when they arise & announced to CARS members through bulletins.
- c. CARS Budget 2019 Expecting deficit this year. Another CRC event has been added to the calendar therefore increase expenses, and 2 sponsors were lost (Dirt Fish & Motul). RSO suggested expenses that could be cut, rather than increase licence fees but the suggestions were not accepted.
- d. Insurance fees ASN Canada has announced a 5% increase in insurance fees, which the CARS Board had not anticipated. As the CARS insurance fund is intended to be revenue/deficit neutral, CARS will be passing the increase on to the clubs and events
- e. Event Permit Fee has been increased by 50% from \$500 to \$750 RSO opposed this but out voted.
- f. CARS AGM January 2020 in Ottawa hosted by RSO
- g. Rally Promotors Association of Canada (RPAC):
 - i. Formed by Keith Morrison, Martin Burnley & Chris Kramer. A CARS affiliated club designed to pursue brining a WRC event to Canada
 - ii. A lot of time has been spend on it so far, with government promised support
 - iii. PN, Defi & LHFR roads are looking at being used. Very positive response from event organizers & from WRC promotor.
 - iv. Aim is for 2023 but WRC are pushing for 2022.
 - v. Very difficult to budget for will need a lot of funding.
 - vi. RPN is worried about being able to run a National event alongside it WRC have no issues with this. Rallye Defi do not see an issue with running the roads in February and then running their national event later on in September as usual.
 - vii. RPAC is seeking operational funding through memberships. RSO members are encouraged to join RPAC. See link on CARS website.

- h. Rally vehicle registration in Western Canada Permanent Registration system in effect in AB, temporary system in BC currently. 4 cars been registered through it so far. Rallyists in QC are now looking to adopt the system & pushing for that to happen not a lot of progress made in QC yet. ON will probably be the most difficult to sell the idea to.

5. Old Business -

- **a. Scrutineers Warren** Warren has followed up with Andrew & is just waiting for him to return from vacation for further discussions into assisting with scrutineering for RSO
- **b.** Competitor Calls Ross Received some good information from the survey that went out last year. LHFR looks to have a lot of chatter from competitors so we will follow up with this after we see the LHFR turnout.
- c. Co-Driver Course Kelly on hold Busy with LHFR will work on for later date
- **d. Motorama 2019** Similar set up to last year. Didn't seem to have as much traffic as usual. Need to look into whether it's useful for use in 2020. Usually organizing team contacts MLRC late fall to see if RSO/Pines is interested
- **e. Sponsorship** Warren has received no response back yet from 2 potential sponsors. He will follow up with them again
- **f. RallySprint Championship** Follow up call with regards to ironing out a few more details is set for May 2nd. David M to send call details to Alan O & Ross W so they can both be involved. Alan is willing to help Darryl with any organizational aspects of the RS championship.

g. RSO AGM -

- i. Elections David voted back in as Treasurer. Warren Haywood voted in as President. Alan Ockwell voted in as VP Performance.
 Alan is looking forward to the position & is hoping he can work on encouraging more 2WD competitors into the sport
- h. CARS AGM 2020 Warren has sent details of the 2 hotels he narrowed it down to, to Debbie at CARS. Both locations near the airport but one more expensive than the other. He will follow up with the more expensive location to see if he can work out a better deal & CARS will take it from there ECRC is on board with hosting their awards ceremony at the CARS AGM and RSQ are interested but the idea has to go in front of the board first for discussion They will let Warren know as soon as it has been discussed.
- i. OPRC Rule Set Warren to send Alan the OPRC rules document to start reviewing whether it needs tidying up/rules adjusted etc.

- 6. ORRC Report Darin
 - a. SNATR#1 Last weekend 15 teams. Good rally, & good roads (lucky with the weather)
 - **b. Spring Run Off (ORRC #4) Apr 27** Port Hope. Need to get a bit more promotion out there for it Everything well underway.
 - c. SNATR#2 & Blossom Raly May 11th
 - **d.** Cross Border Participation JS Besner had mentioned that QC teams were interested in a cross border mini series. A couple of events are interested in this needs futher discussion. (OSCC, MLRC and PMSC). We also need to share the ORRC and Nav calendars with QC.
- 7. **OPRC Report Alan –** no OPRC events since last meeting Next event is LHFR on May 4 (SPDA)
 - a. Black Bear Rally Plan is to allow unlicenced cars to competed (ie. No transit mileage) using the small area at the start of the road as a service area for those vehicles. Main HQ will be at the community centre as it has been in the past. Road permissions are done.
 - b. LHFR
 - i. Ross & Warren were present at the Township meeting & presented the event to them. We still haven't received road permissions. Warren to follow up with tomorrow Tues Apr 16. They presented a number of changes we'd like to see happen but the town turned down all of the suggestions
 - 1. Wanted to change wording from Road maintenance fee to Road Usage fee declined
 - 2. Wanted to reduce fee from \$2000 to \$1500 declined
 - 3. Wanted to streamline procedure to prevent having to do a full powerpoint presentation to the council every year declined.
 - ii. Some remarks made in the local newspaper with regards to communications with local residents. The organizing team will attempt to work with the Umpherson's family at the north end of Umpherson's road to address their concerns of increased traffic. They did note that there were no safety concerns, just an increase in traffic. This will be a project for the organizing team over the next couple of weeks to see how they can address it.
 - iii. 6 entries so far & lots of chatter
 - iv. Dave Maynard is Senior steward with 2 newly trained stewards working along side him very eager
 - v. Organizing team meeting on Wednesday Apr 17 to discuss any issues & finalize items. Volunteers still needed & team will be discussing how many/what roles need to be filled etc. Ross will contact his Tall Pines volunteers if needed.

The trackers are much easier to ship when they don't have a battery with them (easier, safer, cheaper). Competitors have been made aware of this requirement in the event Supp Regs. Alan suggested we also put out a bulletin.

LHFR organizing team will put out a reminder in the form or a Competitor Bulletin & notice on their FB page.

Organizing team will ensure the Course Cars are aware of the requirement
