- 2. Approval of the minutes of the last meeting (Apr 19, 2021) Approved as presented. Mathew/Maynard. Unanimous. Carried
- **3.** Treasurer's Report David Financial documents were sent out ahead of the meeting. The only transaction since the last meeting was the \$600 payment for G&L Insurance

### 4. CARS update - Warren -

- **a.** Financial: Very little change with respect the overall financial status although there have been some licences purchased and issued.
- **b.** CRC:
  - i. RMR postponed the BOD approved the new date for the event which has been set for Oct 8/9 RMR will be a one day event and the organiser is working to get storage/prep space arranged for eastern teams to re-prep for PFR only a week later.
  - ii. BDC supps reviewed and posed
  - **iii.** A discussion took place with respect to what constitutes a National event when some borders remain closed. A variety of perspectives were shared and in the end the BOD agreed that to try to predict what may impact the championship events is too difficult at this point and that letting the season unfold the way it is at the moment is the best course of action.
- c. Insurance:
  - i. CARS has received a quote and package from Stoneridge and Bazinet. At the time of this meeting it was very late coming to us with the difficulties related to securing a provider.
  - **ii.** The BOD agreed in the fall to work with GDS to obtain a package for all of motorsport within the country, GDS found this process extremely daunting working with 3 providers and in the end was unable to secure a package for the affiliated disciplines The ASN plans to continue its work in hopes to table a package for 2022.
  - iii. In the meantime the ASN informed CARS and the regions that they would need to secure their own insurance packages for the 2021 season. Also identified at this time that Everest declined the long time insurer had declined to offer insurance for motorsport at this time.
  - iv. Stoneridge scrambled to find an insurer in a quick move was able to secure Lloyds Markel Canada to provide the insurance required for CARS for the season. This will be provided through Stoneridge and Bazinet.
  - v. Throughout all of this it was becoming clear that the insurance industry as a whole is under some degree of stress and in turn the recognition that premiums would be increasing.
  - vi. Coverages are being affected as well with companies declining coverages for items related to Cyber related incidents and Contagions like COVID for example.
  - vii. As well liability limits for AD and excess medical and weekly indemnity have been reduced.
  - viii. John and Chris prepared coverages based on per car rates for, some adjustments were made based on BOD member feedback.

- ix. A motion was made and adopted to approve the insurance package for 2021.
- **x.** Rate sheet to be issued.
- d. Sponsorship:
  - i. At the time of the meeting John had reported that positive discussions had taken place with Subaru however no concrete agreement had been put in place as Subaru was still hashing out budgets for 2021.
  - ii. Last week John reported that he had the agreement in place for 2021 from Subaru and that he was working with Subaru and our Media provider to nail down the details related to the deliverables for the contract for the 2021 season.
  - iii. I will provide further details as the agreement becomes more finalized.
- e. Rally Cross and Rallysprint:
  - i. The proposed rules had been out for two week review at the time of this meeting, feedback had been incorporated into the documents and sent to the BOD for review.
  - ii. The documents and the feedback were reviewed by the BOD a motion made to approve the rules for both Rallycrss and Rallysprint and was adopted.
  - iii. CARS to issue bulletins related to the new rule sets.
- f. Rally car Registration:
  - i. Work continues in Quebec with Francois meeting with his deputy to discuss similar licensing to AB and BC.
  - ii. Warren working with individuals in ON to secure more resources to approach the related officials.
- g. New President discussion: The CARS BOD working on getting a selection process in place for identifying potential replacements for the president.
- h. Rallysafe:
  - i. Martin B raised the discussion related to rallysafe citing that CARS had been perceived to be early adopters of the Rallysafe system by SAS initially yet has been unable to consolidate and settle on a single tool as events are using both Rallysafe and EZTrak.
  - ii. In the meantime the WRC and ARA have both adopted to use of Rallsafe utilizing some of the functionality in the WRC limited to timing and tracking, to a wider range of functionality use in the ARA including car to car comm, chicanes, quiet zones, and virtual start clocks.
  - iii. There was some lively discussion which took place, the BOD is divided, and recognise that the two systems that are being discussed are not the same and don't offer the same features.
  - iv. The BOD agreed that the ARC would conduct an in depth review of the systems in place and would hopefully be able to get some firmer cost figures nailed down. Easy to get costs for EzTrak but has historically been more difficult to find cost breakdown for Rallysafe.

- i. Studded tire discussion: Martin had shared a winter tire which a western competitor wanted a ruling on if it were legal to use based on the rules. CARS specifies that the tire must be DOT, this particular tire is Italian DOT, the board discussed and agreed that DOT is sufficient designation to maintain the intent of the rule and that the TSMI stud rule remains in place regardless of the origin of the DOT tire.
- j. ASQ:
  - i. Francois shared a letter with the BOD which was issued to RSQ from ASQ requiring RSQ to affiliate with ASQ and pay affiliation fees plus a percentage of their membership fees to ASQ.
  - ii. Francois held a special AGM with his members who agreed unanimously that they would not affiliate with ASQ citing the fact that the ASN has sporting authority over rally in the country who have delegated the sanctioning authority to CARS for all rally related activities.
  - Francois has requested further assistance from CARS and the ASN to assist in the clarification over sanctioning authority for rallysport in Quebec.
  - iv. There have been further developments on this front since the meeting, details will follow in my next report.
- k. GDS the ASN:
  - i. Positive discussions continue between CARS and GDS, their efforts are endless with respect to development of the new ASN.
  - ii. Ron confirmed that he had received CARS affiliation letter and apologized for not getting it noted on the website as an affiliated member.iii. John to stay in contact with Ron.
- Permits: There have been a number of requests recently MLRC & KWRC RallyX events. MLRC for Black Bear Rally. MLRC also requested CARS to allow noninsured vehicles to run at BBR if the event decides to go that route.

- **a.** Rally car registration Warren had reached out for help in this area but it didn't work out so we're back to square one. On going.

# 6. Navigational Rally Report – Louis

**a.** Current calendar – Discover Ontario is cancelled.

- Rest of the season 2 more ORRC events planned for the fall but according to championship rules, there needs to be 4 events for an ORRC championship.
  - Possibility to add another ORRC event in before the end of the year but not a lot of available dates. Spring Run Off was cancelled at the start of the year but might be able to fit it in between President's Prize and Northern Lights Rally
  - ii. There are a couple of SNATRS could they offer ½ points for these events?
  - iii. Possibility of running a double header event. Make it into a longer event & split into 2 legs & score as 2 events
  - iv. ORRC organizers will discuss and see what works best for the championship. They feel no navigational events will happen until stage 2 of the Ontario Reopening Plan.
- 7. Performance Rally Report Brandon Performance events are looking like they might actually be able to happen by the end of the summer
  - a. Performance Rally:
    - i. BBR: Should have the MNR permits in tie and the CARS Permit application has been sent in. Organizers are working on the Supp Regs to include COVID protocols. Ryan Huber is clerk of the course. Event Stewards Vasu and Pete Gulliver have been assigned to the event. They have been discussing allowing non-insured cars to enter (having asked CARS for approval) but this would mean having the service park in the quarry – discussions on going. Roger Sanderson (Event Scorer) is away for BBR weekend so Martin L has offered to score the event.
    - ii. Defi: Organizing team has approval from the municipalities.
    - **iii. RTP:** Everything on track for the event to go ahead. They have eliminated spectator areas and adjusted some routes to avoid certain areas.
  - b. RallyX -
    - MLRC Moved to Free Flow location & now have a new HQ set up there. First event planned for June 20<sup>th</sup>. MLRC are looking to get some vinyls made for the RallyX HQ trailer. Ross is to let Warren know what they need.
    - ii. PMSC Next event at Free Flow June 26
    - **iii. KWRC** Aiming for July 10<sup>th</sup> for first rallyX event
    - iv. MCO The Club runs winter events so we won't see them until 2022
  - c. Rallysprint Everything on track for 3 events this year
  - **d. Co-drivers Course** Free course on Introduction to Co-driving with Alan Ockwell. To focus on timing and control procedures and is being held online July 18.

Aimed at rallysprint competitors predominantly but currently have 32 attendees signed up – some rallysprint competitors & some not. Further promotion on social media will go ahead as the rallysprint competitors have had lots of time to sign up.

- **10. Equipment Managers report Ross Wood** Not much to report. Timing team is getting ready for BDC. The event wants the full RSO Timing set up

  - **a.** First Aid Course Warren to reach out to Jan to see what they are able to offer.
  - b. Changes to Bill 282 Ross re Stunt Driving and Racing'. Some good info to know and understand but bottom line nothing to concern us. Martin has also followed up with Alasdair & he believes it does not pose a problem for Ralllysport
  - c. Performance Rally Fees for 2021 RSO would like to keep fees to a minimum for events.
    - i. **BBR** will not need any road maintenance event organizers requested that the Road Damage fee be wavied. Non opposed Road Damage Fee waived for BBR (\$85/per car).
    - ii. Adjusted RSO Fees for 2021
      - Treasurer suggested \$30/car for RSO Levies to include timing but if any damages occur, events would have to pay for repairs.
        EZTrak fees (if used) are paid directly to Peter MacDonald
      - 2. Waive the listing fee for 2021
      - **3.** \$120/car insurance is still payable directly to CARS.
    - iii. Defi:
      - 1. Current levy is \$80/car for timing, and \$50 RSO Levy.
      - 2. Discussed \$30/car for RSO levy RSO BOD agreed
      - **3.** Timing Ross isn't sure if they will be wanting the lite package or will just use EZTrak for timing.
    - iv. Tall Pines Fees discussion at a later date
    - v. Appendix A Martin & Kelly to update 2021 Appendix A "Covid bounceback fees"
  - d. CARS Bulletin on RS & RX Martin
    - i. Restrictions on passenger sizes have been added
